Must Luv Dogs LLC Policies and Procedures

- Signing up:** All dogs must complete a temperament evaluation. Must Luv Dogs LLC reserves the right to refuse, or to reject at any time, any dogs who will be a safety hazard to itself or the other dogs in our care. This includes, but is not limited to, dogs who are aggressive, anti-social, possessive, anxious, or physically ill.
- Accepted Dogs:** Dogs must be 4.5 months or older to attend daycare/boarding, and all male dogs over 6 months of age must be neutered. Unaltered female dogs may be taken on a case by case basis, and we will not accept any female dogs in heat. We reserve the right to turn away any unaltered females. Should an unaltered female become pregnant while at Must Luv Dogs LLC, we will not be held responsible for the pregnancy or any expenses or puppies resulting from that pregnancy.
- Vaccinations:** All dogs must have current vaccinations against Rabies, DHPP, and bordetella. Rabies and DHPP must be given annually (or every three years; depending upon vaccine type), and bordetella must be given every 6 months in accordance with the law of the City of New York. It is your responsibility to bring Must Luv Dogs LLC a copy of updated vaccinations as needed, or your dog will not be admitted into the facility until we have proof of vaccination.
- Flea Protection:** All dogs are required to wear flea protection. This includes both topicals or flea collars. If your dog has fleas, it will not be allowed into our facility, and no refunds will be rendered. We will not be held accountable if your dog catches fleas, since it is required to be on flea protection.
- Collars and Leashes:** All dogs must be on leash when entering and exiting Must Luv Dogs. All dogs are required to be licensed, and wearing an ID tag. When dogs in our care are taken out for walks or during transportation, they will wear a Must Luv Dogs harness with a choke chain as back up. All dogs are required to wear a flat nylon collar to daycare, and we will not be held accountable for damage to any other kind of collar/harness.
- Boarding Policies:** Our boarding rates are based on a 24 hr period. You must pick up your dog within 24 hrs of dropping him/her off, or you will be charged a daycare fee. If you must pick up your dog on the weekend, and you dropped him/her off during the week before 11am, you must pick up your dog by 11 AM, or you will be charged for daycare.
- Crating:** Must Luv Dogs is a cage-free daycare. Dogs in our care for boarding will be separated at night either by exercise pens or crates. We have the right to refuse dogs for boarding who cannot be crated. We have limited space for dogs that cannot be crated; and offer in-home pet sitting as an alternative if space is filled.
- Food:** For daycare, if your dog needs a meal, please bring in food in a clearly labeled disposable container. We will not store food here, so it is your responsibility to bring food each day. For boarding dogs, please bring food in a plastic bag, and bring enough food to last your dog for his/her stay plus an extra night.
- Late Fees:** Please pick up your dog by closing. Hours are posted on Must Luv Dogs front door. There will be a \$5 charge for the first 15 minutes you are late. If you are later than 15 minutes, timed by our clock, your dog will stay for the night and you can pick him/her up the next morning. If you do not pick up by 8 a.m., you will be charged for daycare. You will also be responsible for the \$45 boarding fee.
- Deposits:** We require a 25% non refundable deposit for all boarding reservations. You will be required to pay the remaining balance on the day of your dog's departure.
- Reservations:** Reservations are required for daycare and boarding, and must be made 48 hours in advance. We will try to accommodate accept walk-ins, but we will not exceed our set dog-human ratio. This is for the safety of all dogs in our care. If you must cancel an appointment, please call us
- Payment:** There are two options for paying for services rendered. You may pay daily with cash, check, or credit card. We will request identification for checks. You may also keep a credit card on file (see below), and your card will be charged the day of your dog's departure (for daycare or boarding). You will receive a receipt upon your dog's departure. For long term boarders, we will charge your credit card weekly for services rendered. We accept Visa and Mastercard.
- Must Luv Dogs LLC reserves the right, without notice, to adjust its rates for services.

MUST LUV DOGS LLC RELEASE FORM

1. I acknowledge that I am the sole owner of this animal, free and clear of all liens and encumbrances.
2. If in my absence, my pet should become ill or injured, or in need of veterinary care, Must Luv Dogs has my permission to consult with my veterinarian and I realize that Must Luv Dogs will make a reasonable effort to bring my animal to its stated veterinarian. If my pet should require immediate care, I hereby give Must Luv Dogs permission to bring my pet to Must Luv Dogs' associate veterinarians' facilities. I understand that I am responsible for all veterinary costs, including the transportation of my pet to and from the veterinarian.
3. I understand that I will be held responsible for my dog's actions while at Must Luv Dogs, which includes, but is not limited to destruction of property, transmission of disease, and injury to other animals or staff. If my dog bites another animal or handler, I understand I will be held responsible and will pay for the other animal's veterinary bills and any other costs incurred because of my dog's behavior.
4. I hereby declare that my animal has not been exposed to any communicable diseases within the last 30 days, and is fully vaccinated in accordance with Must Luv Dogs LLC policy.
5. I understand that Must Luv Dogs LLC's liability, of any circumstance related to the animal, will not exceed the current chattel value of an animal of the same breed as the one in our care.
6. I understand all risks involved with communal boarding. Must Luv Dogs agrees to exercise reasonable care and supervision of all animals in its care. Dogs are encouraged to socialize during their time here, and during that time, my animal may be injured. I will not hold Must Luv Dogs LLC, its guests, or its employees responsible for any injury that occurs while my pet is in their care.
7. I understand that Must Luv Dogs LLC cannot be held responsible for lost, dirty, damaged, or destroyed belongings. I attest to the fact that I am bringing in belongings for my pet even though Must Luv Dogs LLC has warned me that my belongings may not be returned in the condition they were brought in.
8. I understand that Must Luv Dogs LLC will not refund deposits collected for boarding reservations if I cancel my reservation.
9. All photos and video footage taken of my dog while in the care of Must Luv Dogs LLC are property of Must Luv Dogs LLC. This media may be used on the internet, television, and in print ads. I understand that I may purchase Must Luv Dogs pictures from Shutterfly.com for my personal use only.
10. I understand that my dog will be walked on a Must Luv Dogs harness and will have a choke chain as a back up method. If I waive this policy, I will not hold Must Luv Dogs or its employees responsible if my dog should get loose on a walk, or lost.
11. I understand that if I leave my animal at Must Luv Dogs for 72 hours past its designated departure date, and do not contact them to explain the circumstances, my pet will be considered abandoned. My animal then will become property of Must Luv Dogs LLC, and they will do as they see fit with the animal, at my sole expense.
12. I agree to pay for all services rendered at Must Luv Dogs the day of my pet's departure, and understand that my animal will not leave the facility until I do so, and added services due to my non-payment will also be my responsibility to pay before my animal leaves.
13. I waive trial by jury of any and all issues arising in any action, proceeding, or otherwise between myself, my guests, employees and invitees, and Must Luv Dogs LLC, its principals and employees, upon, under, or in connection with this release form and policies form, and my use and the use of my pet at Must Luv Dogs facilities.
14. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as a result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine and award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
15. Must Luv Dogs LLC Release Form and Policies Form contains the entire agreement between the parties. All terms and conditions hereof shall be binding upon the successors and assigns of the parties.
